local Board of Education/ Site Based Decision Making Body to contract membership with the New Mexico Activities Association (NMAA) for the 2014-2015 Academic School Year. By signing this agreement, the school agrees to abide by the NMAA Constitution, Bylaws, rules and procedures established in the NMAA Handbook, and to abide by the decisions of the Executive, Associate/Assistant Directors' offices and the Board of Directors. The undersigned further agrees to comply with all provisions of the NMAA Appeals Procedure as stipulated by NMAA Handbook Chapter XIII.

This contract is to be signed by each school's Superintendent, headmaster, or CEO annually and must be on file in the NMAA office prior to the school or district being permitted to participate in any interscholastic/performance activity, or by September 15th, whichever comes first, of each school year. The NMAA may require additional documents that are related to this agreement which would necessitate completion prior to participation, to include proof of catastrophic health and accident coverage for the member school and its students.

**Responsibilities/Covenants of Member Schools**

It is hereby understood that in consideration of the mutual covenants contained herein, the member school agrees as follows.

- A. To complete all forms/reporting requirements in a timely manner and to provide all documentation required by the NMAA for the member school and its students.
- B. Adhere to all rules, guidelines, regulations and/or policies which are or will be established by the NMAA membership and/or its Board of Directors.
- C. Provide to all interscholastic leaders (coaches, directors, advisors) information that is pertinent to each activity.

I have reviewed, understand and acknowledged with appropriate staff the rules, guidelines, regulations and/or policies of the NMAA Handbook as well as other policies, interpretations and/or statements published through the NMAA.

Further, as a member of the New Mexico Activities Association, we agree that the Principal of each member school is responsible to enforce all rules, guidelines, regulations and/or policies set forth in the NMAA Handbook as well as any interpretations of the same by the NMAA that pertain to the Association's interscholastic/performance activities. We also understand that local district rules may be more stringent than NMAA rules.
