IV. Approval of Agenda **Bill Beacham**

VI. Approval of Meeting Minutes from September 12, 2018 **Bill Beacham**

She indicated that the updated September report had been submitted. The corrections were not reflected in the reports submitted to the Council. Payroll benefits were updated, as the tax tables were incorrect.

A report was included in the packet which shows that SB-9 for 2016 was rolled over to SB-9 31701, 2017. The 2018 dates are actuals, 2019 are projected amounts.

e. Update on NMBT & Purchasing Card

Liza indicated that she is currently researching what Purchasing Card Policies in other school districts look like.

VIII. Presentation of Instruction Plans and Rubrics of Sr. Class Projects, Theater Joey Chavez

Joey Chavez and Barbara Hatch walked the Council through the ‘life’ of a Senior Project. As early as their Freshman year, students are aware that in their Senior year, they are responsible for creating a project. Now working on a trimester format, projects formally begin in February. They must create their plan through a collaborative effort and can be monologues or short plays. They

may also include dance and visual art pieces, but no film. Each student is responsible for their own piece, but other students may be included. These projects are often very personal and emotional based on what is current on the social stage. A rubric is used to grade and a debrief takes place at the end of the productions.

- IX. Approval of Amended Certificate of Resolution Number, Tenure and Qualifications of the Governing Council** Bill Beacham

Greg Hunt made a motion to approve the Amended Certificate of Resolution Number, Tenure and Qualifications of the Governing Council. Paula Tackett seconded the motion. Bill Beacham asked if there was any further discussion needed on the motion. The Council unanimously approved the motion.

- X. Discussion Item: SFPS Tax Levy Elections and Charter Schools Policy** Bill Beacham

On August 21st of this year, SFPS amended their Policy for Tax Elections and stated "Legislatively created charter school not eligible to be included in HB33, SB9 or ETN elections are not eligible to be on the District's tax levy election ballots." Members of the Council and Administrative Staff felt that this was an over-reach, and contacted Dr. Garcia, who agreed with the sentiment. Cindy & Eric will follow up with Dr. Garcia regarding this matter.

- XI. Discussion Item: Governing Council Training Hours** Bill Beacham

During the course of our Charter Renewal, PED informed NMSA that several Council Members did not meet the categorical requirements of annual training. Their number of hours was met. Because of this discovery, NMSA will notify Council Members of all available trainings and track hours and categories in order to eliminate this in the future.

- XII. Discussion Item: FF & E for New Campus** Cindy Montoya

Capital funds will be to furnish and equip the school. As we get closer to the completion of the project, our cash flow will be determined. Access to SB-9, HB33 and ETN funds is critical.

- XIII. Attendance of Governing Council Members at Art Institute Board Meetings** Bill Beacham

Bill Beacham stated that due to quorum rules, the Council members attending Art Institute Board Meetings is limited. Normally, the Council Chair would attend. Dr. Kaplan requested that he go in place of Bill. Cindy Montoya is also in attendance at both meetings. It was pointed out that the role of a Council Member was as an observer.

- XIV. Head of School Report** Eric Crites

In addition to the topics covered in the report, Eric informed the Council of the following:

- Two students. Zev Spaner and Phoebe Miller were recipients of the Miller Scholarship.
- The Council acknowledged Karen Ehlert for her tremendous work on the Charter Renewal.

- A First Aid and CPR Training is will offered in October to interested Faculty and Staff

XV. Admissions Report Cindy Montoya

Cindy stated that the focus of admissions and outreach is all corners of New Mexico. Student grades and/or training or lack thereof are not considered when a prospective student is auditioning.

An amazing Open House was held the previous evening, with over 100 people including 55 prospective students in attendance.

XVI. President's Report Cindy Montoya

Cindy said the that Charter School Administration will be able to successfully take over management of the dorms.

The new website will be launched on Monday, October 15.

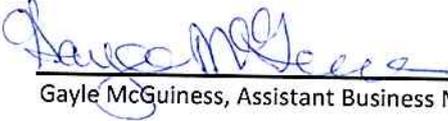
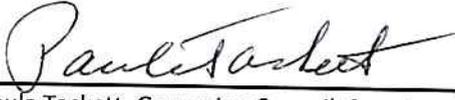
