- IV. Approval of Agenda Bill Beacham

- VI. Update and Action Item: Approval of Lease of New Campus Bill Beacham

Paula Tackett moved to approve the Lease dated June 1, 2019 in substantially the form and with the terms submitted to the Board provided that the lease include Units 1, 3 and 4 of the Sanbusco Center condominium designated in the building plans but excluding square footage retained by the NMSA Art Institute for use for its administration and program and the square

footage to be required for the cafeteria with clarification that the cost provisions for the first year's lease payments shall be not greater than the lease reimbursement assistance authorized by the State plus a percentage amount not to exceed 4% of the School's SEG appropriations authorized for operating expenses not to exceed a total of \$260,000. Dr. Kaplan seconded the motion. Bill Beacham asked if there was any further discussion needed on the motion. There was a discussion following the motion. The motion carried.

VII. Approval of Participation in SFPS Mill Levy Election Bill Beacham

Dr. Kaplan made a motion to approve the participation in the Santa Fe Public School Mill Levy Election (SFPS). Greg Hunt seconded the motion. Bill Beacham asked if there was any further discussion needed on the motion. The motion carried.

VIII. Approval of Resolution to Enter in a Lease-Purchase Agreement Bill Beacham

Paula Tackett made a motion to approve the Resolution to enter in a Lease-Purchase Agreement. Greg Hunt seconded the motion. Bill Beacham asked if there was any further discussion needed on the motion. The motion carried.

IX. Discussion: Mission-Specific Goal(s) for Charter Contract Cindy Montoya

Eric proposed dialogue that was discussed with the Arts Chairs that reads as follows: All students who have attended New Mexico School for the Arts (NMSA) for six or more consecutive semesters will demonstrate proficiency as measured by individual department rubrics for a creative collaborative department project that illustrates competency in their discipline, personal-expression through their art form, and the ability to produce and carry out a comprehensive project.
