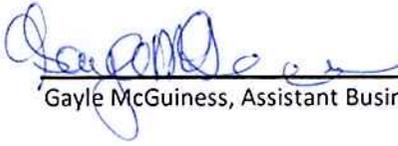
Discussion in Executive Session concluded at 4:11 pm with limited Personnel and acquisition of real property being discussed.
