- XII. Status of Phase II Construction Paula Tackett**

XIV. Admissions Report Cindy Montoya

Cindy reported that 110 students had been accepted for the 2020-2021 School Year – 57% are Caucasian, the remainder are students of color.

In the audition process, it needs to be made clear that a prospective student does not need prior training, but must exhibit passion for the discipline that they are applying for.

Thanks again to the Yates foundation and their generous donation, Francesca Rodriguez has been doing outreach virtually. There was a ukulele give-away following a class!

XV. President's Report Cindy Montoya

The Art Institute is embarking on a website re-do, has they have been able to obtain funding for that project.

The irrigation system was inadvertently disconnected during Phase 1 Construction, causing us to be out of compliance with City ordinances. The cost is \$40,000 to repair. During the Annual PSFA Inspection, we receive an unsatisfactory report for the condition of the parking lot. Repair cost is estimated at \$50,000.

Monthly Department Newsletters will be combined by the Art Institute and sent to all students and families.

Cindy, along with Charlotte Heatherington, are working on a second amendment for the Lease Agreement due to the higher funding from the Charter School's Lease Reimbursement from Public Schools Facilities Authority (PSFA).

Cindy stated that she will provide a written President's Report for upcoming Council Meetings.
