
Pursuant to the August 31, 2010 Bylaws of NMSA, § 2.4, **Annual and Regular Meetings**, the date, time and place of the annual meeting of the Board of Directors shall be set by the Board of Directors and may coincide with the regular meeting of the Board for that quarter. A regular meeting of the Board of Trustees shall be held during either the last or first calendar quarter of each fiscal year for the purpose of electing or appointing Trustees and officers for the coming years and for the transaction of any other business which may come before the meeting. The Board of Trustees may provide by resolution the time and place, either within or without the State of New Mexico for the holding of additional regular meetings without notice other than such resolution
